The certification shall be in the following form: "I certify that these products used for cooling tower maintenance contain none of the 126 priority pollutants (excluding chromium and zinc)."</p> <p>Option 2: If any of the 126 priority pollutants (excluding chromium and zinc) are contained in any treatment chemical product, the permittee shall annually submit engineering calculations which demonstrate that the regulated pollutants are not detectable in the final discharge by the analytical methods in 40 CFR part 136.</p> <p>If the permittee chooses not to comply by utilizing one of the two options provided above, the permittee shall monitor all 126 priority pollutants found in Appendix A of 40 CFR Part 423 monthly due monthly by the 28th of the subsequent month.
