Proposed Rail System to Serve Lumberton Sawmill Complex for Hardy Technologies, LLC

Dear Ms. Bass,

The Walker Associates, Engineers, Planner, Designers, PLLC ("The Walker Associates") has completed the attached Large Construction Notice of Intent form for the above referenced project and have developed the Storm Water Pollution Prevention Plan accordingly for MDEQ's review and comment. A summary of the project and its scope can be found below:

The subject site is the South Lamar Industrial Park in Lumberton, Mississippi. The site is located off Piatonia Road approximately 1.0 miles North of Lumberton, MS. The construction at the site will consist of clearing existing vegetation and linear grading work associated with the installation and construction of a new rail spur to serve Hardy Technologies, LLC in Lumberton, MS and the realignment of an existing gravel roadway Schweirjohn Cemetery Road. The south portion of the site has been developed and construction activities are currently covered under a Large Construction Storm Water General NPDES Permit MSR: 108353. A Jurisdictional Determination was provided for the site on December 9, 2020. A wetlands permit was obtained for the wetland impacts associated with this project on August 13, 2021, Permit No. SAM-2020-01009-AMR (see Appendix C, E, and L of the SWPPP). The total disturbed area will be approximately 26.36 acres. This site has a medium erosion hazard (see soils within Appendix A of the SWPPP). It is in the Pascagoula River Watershed Basin. The receiving streams are Carters Reed Brake & an Unnamed Tributary of Red Creek. Red Creek is listed as impaired under 303(d).

This facility does have a sanitary sewer collection system which connects to the City of Lumberton's collection and treatment system. Attached you will find the City of Lumberton's Intent to Serve letter along with the approved pretreatment permit (Permit No. MSP092450).

## LARGE CONSTRUCTION NOTICE OF INTENT (LCNOI) FOR COVERAGE UNDER THE LARGE CONSTRUCTION STORM WATER GENERAL NPDES PERMIT

### INSTRUCTIONS

The Large Construction Notice of Intent (LCNOI) is for coverage under the Large Construction General Permit for land disturbing activities of five (5) acres or greater; or for land disturbing activities, which are part of a larger common plan of development or sale that are initially less than five (5) acres but will ultimately disturb five (5) or more acres. Applicant must be the owner or operator. For construction activities, the operator is typically the prime contractor. The owner(s) of the property and the prime contractor associated with regulated construction activity on the property have joint and severable responsibility for compliance with the Large Construction Storm Water General Permit MSR10.

If the company seeking coverage is a corporation, a limited liability company, a partnership, or a business trust, attach proof of its registration with the Mississippi Secretary of State and/or its Certificate of Good Standing. This registration or Certificate of Good Standing must be dated within twelve (12) months of the date of the submittal of this coverage form. Coverage will be issued in the company name as it is registered with the Mississippi Secretary of State.

Completed LCNOIs should be filed at least thirty (30) days prior to the commencement of construction. Discharge of storm water from large construction activities without written notification of coverage is a violation of state law.

Submittals with this LCNOI must include:

- A site-specific Storm Water Pollution Prevention Plan (SWPPP) developed in accordance with ACT5 of the General Permit
- A detailed site-specific scaled drawing showing the property layout and the features outlined in ACT5 of the General Permit
- A United States Geological Survey (USGS) quadrangle map or photocopy, extending at least one-half mile beyond the facility property boundaries with the site location and outfalls outlined or highlighted. The name of the quadrangle map must be shown on all copies. Quadrangle maps can be obtained from the MDEQ, Office of Geology at 601-961-5523.

Additional submittals may include the following, if applicable:

- Appropriate Section 404 documentation from U.S. Army Corps of Engineers
- Appropriate documentation concerning future disposal of sanitary sewage and sewage collection system construction
- Appropriate documentation from the MDEQ Office of Land & Water concerning dam construction and low flow requirements
- Approval from County Utility Authority in Hancock, Harrison, Jackson, Pearl River and Stone Counties
- Antidegradation report for disturbance within Waters of the State
