Enclosed is the annual notification for removal of regulated asbestos containing materials at the Baxter Wilson Plant. This notification is submitted to comply with 40 CFR 61.145(a) (4) (iii) which states that the removal of asbestos containing material should be predicted for the calendar year.

This notification is being submitted in the event that the specified quantities of asbestos material are removed during routine maintenance of boiler valves, packing and pipe insulation. Individual notifications will also be submitted as required.

All asbestos containing material will be adequately wet during removal and handling and will be placed in labeled plastic bags. Filled bags will not be dropped or thrown. Waste filled bags will be transported to the local permitted solid waste landfill for disposal.
