L-1		The toxicity of the effluent as the chronic value shall be greater than or equal to 100% and shall be monitored as described in Conditions No. M - 1 through M - 7 of the permit. Chronic bioassay evaluation shall be initiated within 10 days of the date of issuance of the permit and shall be conducted once per quarter for a period of one year.
