LARGE CONSTRUCTION NOTICE OF INTENT (LCNOI) FOR COVERAGE UNDER THE LARGE CONSTRUCTION STORM WATER GENERAL NPDES PERMIT

INSTRUCTIONS

The Large Construction Notice of Intent (LCNOI) is for coverage under the Large Construction General Permit for land disturbing activities of five (5) acres or greater; or for land disturbing activities, which are part of a larger common plan of development or sale that are initially less than five (5) acres but will ultimately disturb five (5) or more acres. Applicant must be the owner or operator. For construction activities, the operator is typically the prime contractor. The owner(s) of the property and the prime contractor associated with regulated construction activity on the property have joint and severable responsibility for compliance with the Large Construction Storm Water General Permit MSR10.

If the company seeking coverage is a corporation, a limited liability company, a partnership, or a business trust, attach proof of its registration with the Mississippi Secretary of State and/or its Certificate of Good Standing. This registration or Certificate of Good Standing must be dated within twelve (12) months of the date of the submittal of this coverage form. Coverage will be issued in the company name as it is registered with the Mississippi Secretary of State.

Completed LCNOIs should be filed at least thirty (30) days prior to the commencement of construction. Discharge of storm water from large construction activities without written notification of coverage is a violation of state law.

Submittals with this LCNOI must include:

- A site-specific Storm Water Pollution Prevention Plan (SWPPP) developed in accordance with ACT5 of the General Permit
- A detailed site-specific scaled drawing showing the property layout and the features outlined in ACT5 of the General Permit
- A United States Geological Survey (USGS) quadrangle map or photocopy, extending at least one-half mile beyond the facility property boundaries with the site location and outfalls outlined or highlighted. The name of the quadrangle map must be shown on all copies. Quadrangle maps can be obtained from the MDEQ, Office of Geology at 601-961-5523.

Additional submittals may include the following, if applicable:

- Appropriate Section 404 documentation from U.S. Army Corps of Engineers
- Appropriate documentation concerning future disposal of sanitary sewage and sewage collection system construction
- Appropriate documentation from the MDEQ Office of Land & Water concerning dam construction and low flow requirements
- Approval from County Utility Authority in Hancock, Harrison, Jackson, Pearl River and Stone Counties
- Antidegradation report for disturbance within Waters of the State

Mr. Gray:

The Mississippi State Department of Health, Division of On-site Wastewater has completed the review of your proposed subdivision. This review satisfies the requirement of Mississippi Code of 1972, Annotated, Section 41 – 67 – 4 (2) and authorizes the Mississippi State Department of Health to accept Notices of Intent. This does not imply or guarantee that any lot will support an individual on-site wastewater disposal system.

In this instance, the site review indicated that the lots have considerable limitations with size and soil texture that will severely limit or preclude the ability of the Division to make recommendations compliant with our Regulations and design standards. Due to these limitations, a feasibility study was required, and the study utilized example engineer designs for certain lots as a basis for comparison against central sewer feasibility. The determination of the study was that it is more feasible to implement engineer designs on each lot than to implement central sewer collection. Most, if not all, lots of the proposed subdivision will likely require engineer designs.

No owner, lessee, or developer shall construct or place on any lot of the subdivision any mobile, modular, or permanently constructed residence, building, or facility which may require the installation of an individual on-site wastewater system, without first having submitted a Notice of Intent to the Division. The developer, owner, or their agent must provide a plot plan, legal description, and application fee to the Division for a soil and site evaluation. Such evaluation shall be conducted with the results returned to the applicant as each Notice of Intent is filed.

As the developer, you must ensure that all local, county, or state requirements are met with regard to this development. This includes but is not limited to the Mississippi State Department of Health, the Bureau of Public Water Supply, and the Mississippi State Department of Environmental Quality regulations.

Should this development be reconfigured in any way, the Division may require additional review prior to acceptance of Notices of Intent for this development.

This letter, while granting eligibility to submit Notices of Intent, should not be understood to constitute an approval of the proposed subdivision, nor in any way suggest that any of the lots of the subdivision as planned are suitable for on-site wastewater systems.
