The results are reported as the effluent value for each parameter on the Discharge Monitoring Report for Jackson POTW, Trahon and Big Creek. The effluent values for Total Nitrogen and Total Phosphorus shall be combined with the effluent values from Jackson POTW, Savanna Street and O.B. Curtis Water Treatment Plant.
