This permit is subject to modification if future evidence, monitoring results, or other information indicates that groundwater or surface water quality is being adversely affected. This permit may be modified to require monitoring of ground or surface water if needed to ensure that water quality is being protect.</p> <p>Operation of the wastewater treatment and disposal system for this project shall cease and connection made to a regional or municipal sewer system when available in the area.</p> <p>The volume of flow (GPD) for the influent to the Grand Bank For Savings, FSB system and subsurface discharge drip field shall not exceed 29,250 gallons per day (initial 69 lots proposed). Any increase in flow for the influent from 29,250 gallons per day (initial 69 lots) must be approved by the Office of Pollution Control.</p> <p>In accordance with the Municipal and Domestic Water and Wastewater System Operator's Certification Act of 1986, this treatment facility must be operated by persons who are certified as qualified to operate the facility.</p> <p>This system may not be put into operation until certification is obtained from the Public Service Commission. Proper operation and maintenance includes adequate laboratory controls and appropriate quality assurance procedures.
