To Whom It May Concern:

Gulf South Pipeline Company, LLC is submitting this Hydrostatic Notice of Intent (HTNOI) requesting authorization for a discharge of hydrostatic test water from their 12-inch-diameter pipeline in Forrest County, Mississippi. The volume of water for the hydrostatic test will be approximately 9,000 gallons from an on-site water well and discharged onto their existing right-of-way (Outfall 001). All water will be discharged at a rate of approximately 500 gallons-per-minute into a haybale structure.

Please find attached a topographic map showing the discharge locations (**Figure 1**) and the HTNOI general permit forms and requisite supporting information (**Attachment A**). The Mississippi Secretary of State Certificate of Good Standing is included as **Attachment B**. The water use permit is included as **Attachment C**. 

#### INSTRUCTIONS

The Hydrostatic Test Notice of Intent (HTNOI) is for coverage under the Hydrostatic Test General Permit to discharge hydrostatic test water. Applicant must be the owner or operator. The coverage recipient is responsible for compliance with the conditions of the general permit.

Completed HTNOIs should be filed at least thirty (30) days prior to the commencement of regulated activity. Discharge of hydrostatic test water without written notification of coverage is a violation of state law.

If the company seeking coverage is a corporation, a limited liability company, a partnership, or a business trust, attach proof of its registration with the Mississippi Secretary of State and /or its Certificate of Good Standing. This registration or Certificate of Good Standing must be dated within twelve (12) months of the date of the submittal of this coverage form. Coverage will be issued in the company name as it is registered with the Mississippi Secretary of State.

IF REGULATED LAND DISTURBING ACTIVITIES ARE TO OCCUR, LIST ACRES DISTURBED: 0

In the case of linear pipeline projects the map shall extend at least one-half of a mile beyond the pipeline right-of-way. The site location and outfalls must be outlined and labeled. ### **SPECIAL TERMS AND CONDITIONS**

**Forrest County**

- Withdrawals from the above referenced Industrial wells shall be limited to a total maximum volume not to exceed 1.84 million gallons per day (mg/d) at a total maximum rate of 4,100 gallons per minute (gpm) or less at this facility. These wells may be pumped in any manner desired to obtain the maximum permitted volume.
- The use of the above referenced wells or any other source of water for once-through non-contact cooling water at this facility is strictly prohibited.
- The Permittee shall allow MDEQ staff access to these wells for water level measurements upon appropriate notification.
- The Permittee shall maintain water use records by recording the daily hours of well operation or reporting metered water use if a MDEQ approved flowmeter is installed. This information shall be made available to MDEQ by participating in the annual Water Use Survey.
- MDEQ maintains the right to place additional restrictions on the use of the referenced wells in the event the local availability of groundwater for priority beneficial uses, such as drinking water supplies, is determined to be adversely impacted.
