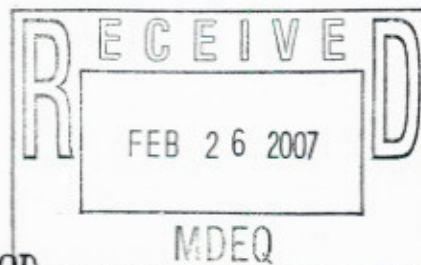

File at least 30 days prior to the commencement of mining; 15 days if a Storm Water Pollution Prevention Plan (SWPPP) is already on file. Lateral expansion of an existing mine that has storm water permit coverage does not require submittal of a new MNOI however, modification of the existing SWPPP to include the expansion is required. Also, according to 40 CFR 122.26 (b) (1) (ii), mining operations that do not discharge storm water contaminated by contact with any overburden, raw material, intermediate products, finished products, byproducts or waste products shall not be required to file a MNOI.
